## 125 Attend CALSTART's Green Airport Fleets Workshop and Expo



The Green Airport Fleet Workshop and Expo was held January 26, 2010 at the Aviation Museum, International Terminal, San Francisco International Airport (SFO).

The Workshop and Expo highlighted new technologies to combat climate change and improve air quality are available now, some with incentives that can cut capital costs by up to 100 percent and fuel costs by as much as 75 percent. Vehicles and equipment--airside ground support equipment, passenger services, cargo and freight operations, and delivery vehicles--all contribute to greenhouse gas and air pollutant emissions of global, local and regional concern.



Alternative fuels, low-emission vehicles, and emission control devices can help meet stricter clean air regulations. In January 2010, CALSTART co-hosted the Green Airport Fleet Workshop and Expo. The gathering of more than 125 attendees and experts saw lively discussion about sources of funding, operational pitfalls, and regulatory mandates. The Expo offered hands-on access to the most fuel-efficient technologies in the world today and was sponsored in part by the East Bay Clean Cities Coalition.

## **AT&T Deploys 1,000th NGV Into East Bay**



AT&T now has 1,000 CNG vehicles in the company's fleet. The company's 1,000th NGV (a van) was recently deployed in Oakland, California. Placement of the 1,000th vehicle into service is part of a \$565 million commitment made in March 2009 to replace more than 15,000 vehicles with more fuel-efficient models by the end of 2018 – at least 8,000 of which are to be NGV's. AT&T operates more than 77,000 vehicles nationwide. EBCCC commends AT&T for their achievement!

## **PG&E Low-Mileage Heavy Duty Natural Gas Vehicles Available**

PG&E will be disposing of 5 - LNG M2 106 chassis (cab only, no body) in the near future. They were part of an earlier LNG truck demonstration project. The engines are John Deere 8.1L 250 HP and were installed at Complete Coach Works. The trucks have low mileage and were in service up until the time that we removed our service bodies from them (approximately 2 months ago). PG&E is trying to gauge the potential interest in these units and are considering sending them to auction or possibly through a direct sale. They are currently at American Truck and Trailer Body Company in Tracy CA. Please note that these are essentially "new" trucks. Mileages are as follows: 4,595, 5324, 9,248, 10,842 and 17,430.
